Change in Representative Executive Officers and Organizational Reform

Aeon Co., Ltd., hereby announces that the following change in representative executive officers and organizational reform were approved at the meeting of the Board of Directors held today.

1. Objective of organization reform

The new organization will be managed under Chairman and President. The position of Officers in charge of each Business will be abolished and the number of Executive Officers will be reduced from 14 to 9 in order to realize a flat organization. Through this, the company will increase the speed of decision making, and further drive Regional Shift, Asia Shift and Digital Shift so as to improve the profitability and pursue further growth of the Group.

2. Organizational reform (as of March 1, 2020)

- (1) To be managed under Chairman and Representative Executive Officer, and President and Representative Executive Officer
- Under Chairman and Representative Executive Officer shall be placed "Supermarket, Merchandise/Logistics" and corporate functions "CFO and Business management, Strategy, Secretary office/Corporate development, CSR & Communications, HR & Administration".
- President and Representative Executive Officer shall directly manage Aeon Retail, Aeon Hokkaido, Aeon Kyushu, Aeon Mall, Aeon Town and Aeon Financial Service. "Digital/China", "ASEAN", "Service/Specialty store" and "Health & Wellness" shall be placed under President.
- (2) Abolish the position of Officers in charge of each Business
- In order to create a flat organization and speed up the decision making process, the position of Officers in charge of the following Businesses shall be abolished: GMS Business, Developer Business, Financial Business, International Business, Online Business, Cosmetic Business.
- (3) Merchandise/Logistics function will be shifted under Officer in charge of Supermarket Business, making the new position Supermarket, Merchandise/Logistics.
- (4) Officer in charge of Logistics will report to Officer in charge of Supermarket, Merchandise/Logistics
- (5) A new position for Officer in charge of Digital/China will be created to manage Digital and China Business.
- (6) Officer in charge of Corporate Planning shall be abolished, and a new position for Officer in charge of Strategy shall be created under Chairman
- (7) The position for Officer in charge of Group Strategy shall be renamed Officer in charge of Secretary Office/Corporate development.
