The Aeon Group's China Headquarters began operations in March 2012 and after sending an Executive Vice President to Guangdong, has since shifted to a "dual headquarters system", with two headquarters based in both Beijing and Guangdong.

Under the "shift to Asian markets strategy" stated in the Group's Medium-term Management Plan (FY 2011 through FY 2013), the Aeon Group's China Headquarters has focused on formulating a business model for growth in the southern part of China, mostly in Guangdong, in addition to establishing functions for the headquarters in Beijing.
